Meat processing such as curing and smoking can result in formation of carcinogenic chemicals including N-nitroso compounds and polycyclic aromatic hydrocarbons. other relevant data to reach conclusions as to the carcinogenic hazard to humans of the consumption of red meat and processed meat.
